TENDER NOTICE

Sealed quotations are invited for and on behalf of the President of India for award of contract to run Girls Hostel Mess and Institute Canteen separately at NSTI (W), D-1, Sector-1, Noida for a period of one year.

The institute has a total strength of about 700 trainees and 65 staff members. The hostel has strength of approximately 300 female trainees. Items of Tea, Coffee, Snacks, Cold drinks and lunch shall be supplied by the contractor to the trainees and staff of the Institute on item rate basis in the canteen. Breakfast, Lunch, Dinner and evening tea with snacks shall be supplied by the contractor to the hosteller on per trainee per month basis in the hostel mess.

Tender documents containing prescribed format and detailed terms and conditions can be obtained from the office of NSTI (W), D-1, Sector-1, Noida on any working day between 3.00 PM 4.00 PM on payment of **Rs. 1000/- (in cash) for Hostel Mess and Rs. 500/- (in cash) for Institute Canteen**. Those who desire to obtain tender documents by post may remit required amount through DD in favour of **Pay & Account Officer, MSDE, New Delhi** alongwith a self address envelop with postage stamp fixed thereon of Rs.10/- for ordinary Dak and Rs. 50/- for registered.

Complete sealed tenders alongwith the following documents in separate envelop for Mess Tender & Canteen Tender should reach this institute **on or before 22.07.2019 up to 2.00PM. No postal delay will be accepted.**

(A) For Mess

- (i) Earnest money deposit of **Rs.35000/- (Rupees Thirty five thousand only)** for Mess tender payable through Bank Draft in favour of P.A.O., MSDE, New Delhi.
- (ii) Firm should have Good Service Tax Registration Number and food license .
- (iii) Latest Income Tax Clearance Certificate with PAN/TAN numbers.
- (iv) Proof of any other taxes as per Government norms.

(B) For Canteen

- (i) **Rs.5000/- (Rupees five Thousand only)** for Institute Canteen payable through Bank Draft in favour of P.A.O., MSDE, New Delhi.
- (ii) Firm should have Good Service Tax Registration Number and food license.
- (iii) Latest Income Tax Clearance Certificate with PAN/TAN numbers.
- (iv) Proof of any other taxes as per Government norms.
